**Collaborative Institutes for  
Strategic Global Partnership & Cross(X)-Innovation Initiative in  
Osaka University Graduate School of Medicine and Osaka University Hospital**

This Rules prescribe what is required for a Collaborative Institutes that agree with Business Objectives (defined below) of Strategic Global Partnership & Cross(X)-Innovation Initiative (hereinafter referred to as “XII”) in Osaka University Graduate School of Medicine and Osaka University Hospital.

**【Definitions】**

**Business Objectives of XII** means:

- To strengthen strategic collaboration with various organizations and institutions worked on medical and healthcare;
- To play a core role (mutual development, realization of future medicine, healthcare innovation, challenge for social issues) for promoting cross-innovation beyond organizations and fields boundaries.

**Cross(X) Industry Discussion** means the interaction between Collaborative Institutes and laboratories of Osaka University as a first step in industry-academia co-creation.

**Fiscal Year** means, from April 1 to March 31.

**Joint Research Chair** means a research organization created within Osaka University using outer funds provided by a company or other institutions.

**Last Half of Fiscal Year** means, from October 1 to March 31.

**Medical and Healthcare (M/H) Partnership Agreement** means partnership agreement signed between Osaka University Graduate School of Medicine and Osaka University Hospital with various organizations for the purpose of strengthening of collaboration between organizations with organizations, accelerating commercialization by open(cross) innovation, and challenge to the social problem.

**Project Design Meeting** means a small meeting assembled Collaborative Institutes and the laboratories of Osaka University under specific themes.



**Visiting Academic Staff** means academic staff and researchers accepted by Osaka University to engage in activities on a gratuitous basis to promote the education and research activities of Osaka University.

### **1. Collaborative Institutes**

- 1.1. Institutes agreeing with Business Objectives of XII may apply for participation in Collaborative Institutes.
- 1.2. Collaborative Institutes shall promote together with XII for business activities.

### **2. Approval of Collaborative Institutes**

Collaborative Institutes shall be approved by authorization of Dean of Osaka University Graduate School of Medicine and Director of Osaka University Hospital.

### **3. Contribution**

- 3.1. Collaborative Institutes must pay contribution (JPY 600,000.00) each Fiscal Year.
- 3.2. Collaborative Institutes shall pay half of the contribution if they enroll in during the Last Half of Fiscal Year.
- 3.3. The payment is due by the end of the following two months after the invoice issued.
- 3.4. Only JPY shall be accepted.

### **4. No refunds on Contribution**

No refunds on paid contribution.

### **5. Activities**

- 5.1. Collaborative Institutes will collaborate with XII and participate in the following activities:
  - 5.1.1. Research exchanging activities based on Open Innovation toward establishment of joint research or Joint Research Chairs with various organizations and institutions;
  - 5.1.2. Activities for, Planning, operating, or supporting to hold, seminars/workshops/symposiums/sectional meetings, related to promoting the collaboration regarding research and commercialization;
  - 5.1.3. Activities for support market research, intellectual property strategies, commercialization, and the operation of ventures in cooperation with support teams in M/H Partnership Agreement institutes;
  - 5.1.4. Activities for Project Design Meeting;

- 5.1.5. Activities for Cross(X) Industry Discussion;
  - 5.1.6. Activities for human resource exchange between Collaborative Institutes;
  - 5.1.7. Joint research activities with the laboratories of Osaka University Graduate School of Medicine.
- 5.2. Visiting Academic Staff belonging to Collaborative Institutes are possible to utilize some rooms and facilities at Osaka University for promoting activities with XII.

## **6. Withdrawal**

- 6.1. The Collaborative Institute who would withdraw must submit Notification of Withdrawal no later than six months prior to the date on withdrawal.
- 6.2. XII could expel the collaborative institute who disturb XII's activities in much worse manners.

## **7. Supplemental Provisions**

This Rules shall be effective from April 1, 2020.
