Based on the University of Osaka's Admission Policies, in order to nurture personnel suited to its education objectives, the Graduate School of Medicine is looking for individuals who:

- * meet the knowledge requirements noted below and aim to contribute to the advancement in medicine, medical care, and life science.
- * aim to secure quality of healthy life for the local community as medical professionals.
- * hope to assist in nurturing excellent personnel responsible for the next generation.

The master's course welcomes persons possessing the following qualities:

- (1) English proficiency capable of reading theses written by western researchers and writing theses in English.
- (2) A liberal arts level of knowledge, necessary for conducting research in life science fields as well as an undergraduate or higher level of basic knowledge in a specialized area.
- (3) An excellent sense of purpose and a sense of ethics, necessary for conducting medical research.

[Selection Scheme]

An entrance examination for Master's Course is conducted in order to accept the diverse students matches to our requirement.

[Evaluation points of above qualities and abilities]

(1) will be evaluated in the English external examination. (2) and (3) will be evaluated in the oral examination and submitted documents and other.

3. Qualifications:

Applicants must meet one of the following qualifications:

- (1) Individuals who have graduated or expect to graduate from a university or a professional university by March 31, 2026.
- (2) Individuals who have received or expect to receive the equivalent of bachelor's degree from a University by March 31, 2026.
- (3) Individuals who have completed or expect to complete sixteen (16) years of formal education overseas by March 31, 2026.
- (4) Individuals who have completed or expect to complete the equivalent of sixteen (16) years of formal education overseas through the completion in Japan of a correspondence course offered by a school in that country by March 31, 2026.
- (5) Individuals who have completed, or expect to complete the relevant coursework designated separately by the Minister of Ministry of Education, Culture, Sports, Science and Technology (MEXT) at an educational facility in Japan which ranks in a foreign country's educational system as providing the same level of curriculum as a university in that country (limited to those facilities recognized as providing the equivalent of sixteen (16) years of formal education in that country) by March 31, 2026.
- (6) Individuals who have received or expect to receive the equivalent of a bachelor's degree through the completion of coursework (*1) which requires three (3) or more years of study at an overseas university or school (*2) by March 31, 2026.
(*1) Including but not limited to the completion of a correspondence course in Japan offered by a school overseas and which ranks in an educational system overseas as providing the same level of curriculum as a university in that country designated by Item (5).
(*2) Limited to schools evaluated by organizations that are certified by overseas governments, or relevant agencies, on the comprehensive progress of their education and research, or schools which are designated separately by the Minister of MEXT).
- (7) A person who has completed or is expected to complete a professional course at a vocational school with a length of course term of four years or more and meets the criteria specified by the Minister of MEXT as specified separately by the Minister of MEXT or after the date specified by the Minister of MEXT, or a person who is expected to complete such a course before March 31, 2026.
- (8) An applicant designated by the Minister of MEXT (under Minister of Education, Culture, Sports, Science and Technology Public Notice No.5,1953)
- (9) Individuals who have been enrolled at a graduate school in Japan pursuant to the provision of Paragraph 2 of Article 102 of the School Education Law and who are recognized as having adequate academic skill to study at the Graduate School of Medicine [Refer to "4. Qualifying Review"].
- (10) Individuals who have been enrolled at a university of a professional university in Japan for at least three (3) years and who are recognized by the Graduate School of Medicine as having acquired the prescribed number of credits with exemplary grades [Refer to "4. Qualifying Review"].
- (11) Individuals who have completed, or expect to complete the relevant coursework designated separately by the Minister of Ministry of Education, Culture, Sports, Science and Technology (MEXT) at an educational facility in Japan which ranks in a foreign country's educational system as providing the same level of curriculum as a university in that country (limited to those facilities recognized as providing the equivalent of eighteen (15) years of formal education in that country) [Refer to "4.

Qualifying Review”].

(12) Individuals who are at least twenty-two (22) years of age at the time of March 31, 2026 and who are recognized by the Graduate School of Medicine as having academic capabilities equal to or exceeding those of an individual who has completed a course at a university or a professional university, based on a separate admission qualification evaluation [Refer to “4. Qualifying Review”].

(Note) "a university", "a professional university" in (1), (10), and (12) indicate ‘universities’ or ‘professional universities’ in Japan as stipulated by Article 83 of the School Education Law.

4. Qualifying Review:

Among the Qualifications mentioned above, those who wish to apply (9), (10), (11) or (12) * must undergo a “Qualifying Review” prior to the application period. Individuals who pass the review may apply for the master entrance examination

*The criteria for academic background and research periods (years of experience) to apply for Qualifying Review (12).

Educational background	Research period after the latest academic year (years of experience)
(a) Graduate of a junior college (two-year course)	2 years or more
(b) Graduate of a junior college (three-year course)	1 years or more
(c) Graduate of a technical college	2 years or more
(d) Graduate of a specialized course (two years or more) of a specialized training college	More than the period calculated by subtracting the term of study in a specialized training college (specialized course) from six years.
(e) Graduate of a Japanese campus of a foreign university, international school, specialized training college (except specialized courses), or other schools and educational institutes in Japan and overseas. 6. Details of Entrance Examination and Marks allotted

- (1) Selection of applicants for admission shall be conducted based on English (TOEFL, IELTS or TOEIC score, statement of purpose, Academic Transcript, and submitted documents.
Oral Examination test may be conducted only for those who have passed the document-based first screening selection.
Successful applicants will be sent ‘Oral Examination slip’ and ‘precautions for applicants’
Applicants who are eligible to take the oral examination will receive "Oral Examination slip" and "Test Taker Notes", etc., and "Notification of failure" will be sent to those who fail by registered mail (dispatched from the Graduate School on July 31, 2025).
- (2) The final successful applicants will be judged comprehensively from the academic achievement test (English and oral examination), the reasons for applying/ the research content report, and other submitted documents.
- (3) Depending on the result of the comprehensive decision, admission may not be allowed regardless of the number of applicants.

*1 Applicants are possible to enter the examination room 45 minutes prior to the examination starts. (at the Faculty of Medicine Lecture Building)

Please meet at the Faculty of Medicine Lecture Building 30 minutes prior to the exam time and be seated in the designated place.

*2 Please present your Examination Slip when you enter the place for examination.

*3 In case of late, inform the staff at the entrance of the examination hall up to 30 minutes after the start of the examination.

Generally, the examination will not be accepted after 30 minutes have passed since the start of the examination.

*Details such as meeting time will be instructed in the "Test Taker Precautions" sent to those who passed the first screening test.

【Process for administering the Oral Examination】

In the Oral Examination applicants will be asked whether they are learning the level of understanding and basic knowledge about (1) the research that applicants have done or are conducting at a university faculties., or (2) the research that applicants want to conduct after entering the Graduate School. In principle, we ask about (1) and (2) if there is no one that falls under (1).

The applicant will first give a presentation within 7 minutes, and then will be followed by a Q&A session by the interviewer.

The point of evaluation is not the amount of exhaustive knowledge that is answered in a typical paper test.

The key point is whether the applicant has qualities such as enthusiasm, attitude, creativity, judgment, and logical thinking skills when conducting research as a graduate student.

In the case of (1), be able to talk in detail and logically in your own words about the purpose, importance, research method and its principles, possibility of application, social significance, etc. about the research themes conducted or conducted in the faculties of the university.

In the case of (2), be able to explain the research contents as specifically and logically as possible while describing the same items as (1).

(Continued)

(1) and (2) In any case, print 6 copies of the Oral Examination Form (prescribed form) that summarizes the contents in one sheet using charts etc. as appropriate, **bring 6 copies on the day of the oral examination (Friday, August 15, 2025) and submit it according to the instructions of the person in charge.** It can be created by hand or on a computer, but it should be below the underline of the format. The languages used are Japanese and English only.

Note:

In Oral Examination, applicants can hold their Oral Examination Form only. After submission of 6 Forms, one will be given back to the applicant for him/her to make a presentation accordingly.

Applicants are not allowed to choose the Form from out of the 6 by themselves.

It is not possible to bring any presentation notes to the examination room. Speak in your own words.

In addition, it is not possible to use an electronic display device (personal computer, tablet, etc.) nor distribute materials other than prescribed Oral Examination Form to the interviewer.

8. Announcement of Successful Candidates:

Successful applicants will be posted on the Graduate School of Medicine's website (https://www.med.osaka-u.ac.jp/admission/admission_master) at 13:30 pm on the date indicated on page 2. Successful applicants will also individually receive an acceptance letter. The letter will be sent by registered mail to the address on the label affixed to the SASE. If you need to change the address, please contact the Graduate School of Medicine's GAKUSEISHIEN-KAKARI by Sep. 1 (Mon), 2025. (*Only successful applicants will individually receive a letter.)

Please note that no inquiries about the results are accepted.

In case the number of admission procedures is less than the number to be admitted, measurement of additional pass may be taken from mid-January to early March. In that case, we will contact you individually to the phone number and e-mail address listed in the application form.

9. Enrollment Fee and Tuition Fee:

Enrollment Fee: 282,000yen

Tuition Fee : 267,900 yen/Semester (535,800 yen/year)

*Changes may occur to enrollment fee and tuition fee.

*Should tuition fees change while the student is attending the school, the new tuition fees will apply at the time of the change.

*Japanese government scholarship students do not need to pay the enrollment fee or tuition fee.

The University of Osaka offers tuition waiver system (Tuition Waiver System for Honor International Students) for privately-funded international students who are recognized as excellent in the graduate school entrance examinations in order to further strengthen research capabilities and promote the acceptance of international students.

This entrance examination is subject to the Tuition Waiver System for Honor International Students. The successful applicants for this program/course are eligible for the Tuition Waiver System.

10. Admission Process:

The period for the admission process is planned for late of February 2026. Documents relating to the admission process should be sent by registered mail by the late of January 2026.

Documents will be mailed the address that applicants submitted

It will be mailed to the address on the name slip submitted at the time of application.

*Please fill in the address label. Contact the Graduate School of Medicine's GAKUSEISHIEN-KAKARI immediately if there is any address change after application.

*Failure to complete the admission procedures shall be regarded as refusal of admission.

*Junior Residents in training are not allowed to be enrolled in the Graduate School of Medicine at the University of Osaka. Junior Residents are required to suspend or cancel their Senior Resident training before enrollment.

Please contact other universities to confirm the necessary procedure for unenrolling. A document to prove unenrollment such as a Certificate of Withdrawal or Certificate of Graduation is required to be submitted after entering the Graduate School of Medicine at the University of Osaka.

11. Disclosure of Entrance Examination Results:

The total score of "English" and "Oral Examination" will be disclosed based on the request from the applicant. However, we will not accept claims from those who failed the first screening test or those who were absent from Oral Examinations.

- (1) If the application documents contain any falsifications, admission may be revoked even after being admitted to the university.

13. Policy on Handling Personal Information:

(1) Names, addresses, and other personal information obtained through the application procedure will be used in the Entrance Examination Process, Announcement of the Successful Applicants, Admission Procedures, and to distribute program leaflets.
